## Missouri Wilderness In The News

On December 15, 8<sup>th</sup> District Representative Jo Ann Emerson's weekly radio address was regarding Missouri's forests, entitled: "*The Forests and the Trees*". This first caught our attention in the *Shannon County Current Wave* where it appeared as a guest Opinion piece. It has been printed in several south Missouri papers. While there are some issues that can be inferred from the article which MWC may not support, Ms. Emerson does make a clear endorsement of the value of Wilderness Areas and wildlands in the overall spectrum of Missouri's forest assets, both from an environmental and economic perspective. With this in mind, MWC sent a letter to Jo Ann, expressing our support for that aspect of her article. The column can be found at [Jo Ann's official website](#). Our letter to Rep. Sue Gustafson had two great articles about the Wilderness Proposal in recent editions of [Audubon Society of Missouri's](#) newsletter, *The Bluebird*, and [St. Louis Audubon Society's](#) newsletter, *Talefeathers*. Both of these Audubon organizations have endorsed the Wilderness proposal. Sue's articles make the critical point that all seven of the proposed areas "...lie within designated Important Bird Areas and provide habitat for species of concern such as Cerulean Warbler, Swainson's Warbler, and Bachman's Sparrow." Thanks Sue, for your work on these fine articles!

Finally, the December issue of [River Hills Traveler](#) had a short opinion piece about the Wilderness Proposal - specifically about the lands within RHT's readership area

(southeast Missouri Ozarks). The piece was written by the newspaper's retiring editor, Bob Todd. RHT has also contacted MWC about a possible Wilderness article for an upcoming issue.

## Van East Trip

Scott Campbell and John Roth took a day hike into the Van East Mountain Proposed Wilderness a few weeks ago - took some great pictures, and provided some excellent comments about the trip. Many thanks to Scott and John for letting MWC reprint a portion of their comments.

Scott: "The place feels just as wild as Trackler Mtn. There are a few jeep paths up there and that's all the trails we saw. Great place to bushwhack. The glades offer great views and on sunny spring and fall days I imagine it would be like heaven up there. Lots of perfect spots to sit for a spell in the glades and have lunch or just relax. The pines on the distant hills were wondrous to behold. Due to the wet weather the mosses and lichens were really glowing green and though the forest was at rest and the silence of winter was upon us we did get to enjoy the sound of water as it flowed down the mountain through rock strewn notches seemingly talking and laughing all the way to the creek in the valley below."

And John: "A relatively small area, but with a viewshed that pulls in so much---Blue and Smith Mountains are prominent to the south but even Trackler and Kelley can be seen from the magnificent glades on the south-face of Van East. Unlike the view from Goggins or Bell, the surrounding "billion year old" mountains seem so close, so intimate. (If you've seen Marlow from Black, you'll know what I mean.) Van East was a visual feast, especially after a few days of rain. The cascading waterfalls to the north, especially by the "slot" running uphill from the spring we found, were breathtaking. I could probably write a short novel about Van East.....Absolutely stunning."
